Competition Rules:

The Powell River Working Equitation Classic is licensed by Working Equitation Canada (WECAN). The competition will follow Working Equitation Canada 2026 Rules. The rules and 2026 dressage tests can be found on the WECAN website: <http://www.workingeq.ca>

A horse/rider pair is considered an entry. A horse/rider entry may compete in only one level per show. At licensed shows, a horse may be ridden a maximum of twice with different riders and the riders must be entered in different Levels. Exception: Two youths or a youth and adult can share the same horse if competing in Introductory (Level 1).

Allowances for tack and attire are in the WECAN rules. Any tradition or discipline of tack is allowed within the parameters of WECAN rules.

Any breed of horse or mule is allowed to compete. Horse age restrictions do apply. Horses must be at least 4 years of age as of January 1st in the competition year to compete in Levels 1 to 2. A horse must be at least 5 years of age as of January 1st in the competition year to compete in Levels 3, 4 and 5. A horse must be at least 6 years of age as of January 1st in the competition year to compete in Level 6 and 7.

Riders under 18 years of age must have permission to ride in the competition as indicated by a signature from their parent or guardian. All riders under 18 years of age must be accompanied by an adult. All riders under 18 must wear an ASTM approved helmet while mounted anywhere on the show grounds.

Horses must be recorded with WECan if you wish to have your results tracked. A Horse Recording Form is available on the WECan website in the Members Area, List and Forms. Only recorded horses will have their scores tracked for qualification towards-achievement awards with WECan.

All Riders and horse owners are required to have a current HCBC Membership (or equivalent) as well as a WECAN membership.

All horses must wear their entry number while exercised or ridden anywhere on the show grounds.

Dressage test readers are allowed for Levels L1 to L3 ONLY. Please note that the show will not be providing readers for these levels. However, the show would be happy to accept volunteers to read for competitors.

Facility Rules:

Dogs must be on leash at all times and be well-behaved. Garbage cans will be provided on the show grounds. No Littering! Clean up after your horse anywhere on the show grounds. Additional rules will be posted at the show grounds.

Camping:

Camping is available on site and is mandatory if your horse is stabled on the grounds. Please fill out camping details on entry form. Potable Water is not available on site. Overnight stays with your horse is included in your stabling fee. No showers on site. We are not a public campsite.

Stabling:

Outdoor stalls/holding corrals are available for overnight or day use rental. Please fill out the stabling section on the entry form. Please provide water buckets, feed tubs, shavings (if desired, stall floors are dirt) and hay nets. Bring your own stable cleaning equipment. Must be fully cleaned before leaving the grounds. A \$40 stall cleaning deposit (cash or cheque) is required at check in, and will be returned once stall has been cleaned and inspected. Horse water is available on site.

Powell River Therapeutic Riding (located on the same exhibition park grounds) has also offered overnight boarding options as well for our out-of-town participants. They require proof of vaccination. Limited Spaces available! These can be booked through the show secretary. \$25/night

Prizes:

Ribbons are awarded for 1st to 6th place in each Level with 7 or more riders and 1st to 4th in levels with 6 or less riders. Each trial for each Level will be awarded with 1st to 3rd placings. Points are also recorded by WECAN for Achievement and Milestone awards.

Entry information:

Only one class can be entered for each horse/rider combination.

An entry is not considered complete until all fees, including WECAN and HCBC numbers have been presented and have been paid. The Show Committee has the right to not accept any Entry. The number of entries accepted will be determined as entries are received. In the event of an entry being received after the show is full, those entrants will be notified and given the opportunity to be placed on a wait-list.

Cancellation Policy:

Withdrawals will be accepted if medical issue with Doctor/Veterinarian letter is presented and a refund will be granted less \$40.00 administration fees. If withdrawal is requested on or after July 9th no refund will be granted.

Waivers:

All 3: PRTRC, PRTRA and WECAN liability waivers must be signed. HORSES ARE NOT TO BE UNLOADED AT VENUE UNTIL THE WAIVERS HAVE BEEN SIGNED.

Youth not being accompanied to the show by their parent or guardian must have waivers completed and signed before arriving (available through the Show Secretary). Youth must be accompanied by an Adult.

A note about the location:

Powell River is a rural location, a few things to note!

We recommend reservations with BC Ferries for your trip over. Contact them directly to do so.

There is NO large animal vet in Powell River. Come prepared with your first aid kit and any medications you may need. Epona Equine Vet out of Comox BC services us over the phone in the case of emergencies; however anything needing vet treatment needs to go to Comox or beyond.

Make your trip for the show a little vacation; Powell River Trail Riders Club has a lovely arena, outdoor stalls, green space, clubhouse on site and, access to beautiful forest trails and the lovely Hammil Lake right across the street.
